

CMP Software Developers

There are **two** types of software products to choose from:

Commercial software developers

- Private company providing local data collection systems to critical care units for a profit.
- will usually provide a maintenance, support service and software updates as needed.
- are likely to have a regional or national coverage.
- are likely to use more up-to-date technologies and may provide additional functionality to enable the collection of other related data or a link to other hospital systems.

Non-commercial software developers

- Hospital/Trust/Network based individual/organisation providing local data collection solutions to local critical care units at cost/for free.
- may provide a maintenance and support service.
- may be limited to specific geographical area.
- may offer additional functions.

Advice for units

ICNARC recommends that when choosing the appropriate software units should:

- find out whether costs are annual or 'once-only' and if these cover support and maintenance;
- ask prospective software suppliers to demonstrate the software to unit staff (particularly the data collector);
- discuss the proposed software choice with the Trust IT department;
- ensure the software has passed ICNARC's rigorous compliance testing process; and
- ask other units who already use the proposed software solution how they find its use and application (where relevant).

CMP compliant software developers provide software that meets strict CMP dataset technical specifications and that have been deemed as 'CMP compliant'.

CMP registered software developers (non-compliant)

Registered software developers have been granted access to the full complement of dataset specification documents required to develop CMP-compliant software, but have either:

- not yet submitted test data (i.e. non-active); or
- submitted test data, but are currently in testing phase.

ICNARC will **not** accept data submission from units using non-CMP compliant software unless submitted as a pre-agreed 'test file'.
