## Ensuring a high quality resuscitation service

If you or your loved one/family member suffer a cardiac arrest in hospital they should receive high quality resuscitation and post-resuscitation care. The government requires NHS hospitals to provide an effective resuscitation service. This hospital is regularly measured by two health charities working together, Resuscitation Council UK and ICNARC (Intensive Care National Audit & Research Centre).

Information about you/your loved one's cardiac arrests, responded to by the resuscitation team in this hospital, are collected by hospital staff. This is then sent to ICNARC who analyse the data and send the results back to the hospital. The hospital can use these results to improve the care they provide to their patients. This process is called an audit. This audit is called the National Cardiac Arrest Audit (NCAA).

## Who collects this information?

A trained member of staff from this hospital collects the information (data) about each in-hospital cardiac arrest responded to by the resuscitation team. They then enter that data onto a secure website which can only be accessed using a username and password.

## What information is collected?

- Patient details – NHS Number, date of birth, sex, ethnicity;
- Details of admission/visit to the hospital – date of admission, reason for being in the hospital (e.g. surgery, outpatient, visitor);
- Details of cardiac arrest – date and time, location of patient while having cardiac arrest, type of heart rhythm during cardiac arrest;
- Details of outcomes – reason why resuscitation stopped, whether patient survived cardiac arrest, where patient went following cardiac arrest, date of discharge

No names or addresses are collected

## How is this information used?

The information (data) collected in each hospital is sent to ICNARC. ICNARC brings together and analyses data from hospitals across the UK. They then send out a confidential report to each hospital. This report shows how they compare with similar hospitals in the UK in terms of the care they provides and the results of this care. This helps ensure all hospitals consistently maintain the best possible patient outcomes. ## How secure is this information?

ICNARC has a very secure computer system and strict information security policies that are reviewed annually.

## Does my information need to be included?

If you don't want your data to be used, you have the right to request that it isn't sent to ICNARC. You can do so by discussing this with a member of your healthcare team. This will not affect the care and treatment provided.
